**Sub: Voting results of the Postal Ballot process (including voting through electronic means) conducted by the Company, pursuant to Regulation 44 of SEBI (LODR) Regulations, 2015 (Listing Regulations)**

**Ref:** BSE- 540210; NSE – TMRVL

Pursuant to section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014, the Company had sought approval of the Members for sale of the select Inventories and Store Assets pertaining to the Trademark License Agreement executed between the Company and Being Human - The Salman Khan Foundation to Four Aces Fashion House Private Limited by way of Postal Ballot including voting through electronic means (‘ e-voting’ ) in accordance with Section 108 of the Companies Act, 2013 read with the Companies (Management & Administration) Rules, 2014 and Regulation 44 of Listing Regulations. The voting period commenced on Wednesday, 18<sup>th</sup> March, 2020 at 9.00 a.m. (IST) and concluded on Thursday, 16<sup>th</sup> April, 2020 at 5.00 p.m. (IST). During this period, the Members holding shares, either in physical or in dematerialized form, as on close of business hours on Friday, 6<sup>th</sup> March, 2020 were eligible to vote on the resolution as stated in the Postal Ballot notice dated 7<sup>th</sup> March, 2020.

Mr. Nitin R. Joshi, Practicing Company Secretary was appointed as the Scrutinizer for the Postal Ballot and e-voting process, to scrutinize the voting in a fair and transparent manner. A consolidated report on the entire voting process including e-voting has been received from the Scrutinizer.

The voting results of postal ballot, pursuant to the time limit as stated under Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with applicable provisions of the Companies Act, 2013 (‘Regulation’), was scheduled to be declared on or before Saturday, 18<sup>th</sup> April, 2020. However, as informed vide our letter dated 15<sup>th</sup> April, 2020 (‘said letter’), on account of the lockdown imposed by the Government of India w.e.f. 24<sup>th</sup> March, 2020 as a preventive measure against outbreak of Covid-19 pandemic in India, the offices of the Company, Registrar and Share Transfer Agent (‘RTA’) of the Company and the Scrutinizer, appointed for conducting the Postal Ballot process, were shut temporarily.

Further, as informed in our said letter, on 11<sup>th</sup> April, 2020, the State Government of Maharashtra has further extended the lockdown in the state of Maharashtra till 30<sup>th</sup> April, 2020 as the positive cases of coronavirus continued to rise in the state of Maharashtra. Additionally, on 14<sup>th</sup> April, 2020, the Government of India has further extended the lockdown till 3<sup>rd</sup> May, 2020 which was followed by two-week extensions starting 3<sup>rd</sup> May, 2020 and 17<sup>th</sup> May, 2020. In light of the aforesaid circumstances, there was an unpredictable delay in obtaining the voting report from the RTA and the Scrutinizer and consequent submission of Postal Ballot results, as per the requirements under the Listing Regulations. The Lockdown further got extended till 30<sup>th</sup> June, 2020, however, with effect from 8<sup>th</sup> June, 2020, the Government of Maharashtra has, albeit with limited capacity, ordered for reopening of private offices and establishments. Pursuant to which, the RTA was able to access the physical postal ballot forms and subsequently on 13<sup>th</sup> June, 2020, the Scrutinizer has submitted its report on the voting for the Postal Ballot.

The consolidated voting results in terms of Regulation 44 of SEBI (LODR) Regulations, 2015 and the Report of the Scrutinizer dated 13<sup>th</sup> June, 2020 are enclosed herewith.

Based on the consolidated report of the scrutinizer, the resolution as set out in the Postal Ballot notice has been duly approved by the Members of the Company with requisite majority.

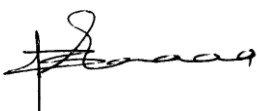

## REPORT OF THE SCRUTINIZER

Dear Sir,

I, Nitin R. Joshi, a Company Secretary in Practice, have been appointed as a scrutinizer for postal ballot voting process including voting by way of electronic means/e-voting (hereinafter referred as "the said Voting Process") by The Mandhana Retail Ventures Limited (the Company) for the purpose of scrutinizing the said Voting Process under the provisions of Section 110 of the Companies Act 2013 (the Act) read with the Companies (Management and Administration) Rules, 2014 and the applicable provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The Management of the Company is responsible to ensure the compliance with the requirements of the Act and applicable rules relating to the said Voting Process on the Special resolution contained in the Postal Ballot Notice (the Notice) dated 07.03.2020 issued under Section 110 of the Act. My responsibility as a scrutinizer for the said Voting Process is restricted to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolution stated in the Notice based on the reports generated from the e-voting system provided by Central Depository Services (India) Limited (CDSL), the authorized agency engaged by the Company to provide e-voting facilities and physical postal ballots received from Members.

The Company has appointed me as the scrutinizer for the said voting process in respect of the following resolution:

Resolution No. 1: Special Resolution for Sale of the select Inventories and Store Assets pertaining to the Trademark License Agreement executed between the Company and Being Human - The Salman Khan Foundation to Four Aces Fashion House Private Limited:

I further state that:

1. Sending of e-mails or dispatch of the Notices alongwith Postal Ballot Forms to all the Members, whose names appeared in the Register of Members / Records of Depositories as on 06.03.2020, have been completed by the Company on 16.03.2020. The Members of the Company as on cut -off date i.e. Friday, 06.03.2020 were entitled to vote on the resolution contained in the Notice.
2. The Particulars of all postal ballot forms received from the Members have been entered in a separate register maintained for the purpose.
3. The e-voting commenced from Wednesday, 18.03.2020 at 09.00 AM and ended on Thursday, 16.04.2020 at 05.00 PM.
4. I have downloaded the data of e-voting after the e-voting module was disabled by the Central Depository Services India Limited (CDSL) on 16.04.2020 at 05.00 PM.
5. The postal ballot forms were kept under safe custody of Link Intime India Private Limited, the Registrar and Share Transfer Agent (RTA) of the Company, before commencing the scrutiny of such postal ballot forms.
6. All postal ballot forms received up to the close of working hours (i.e. 05.00 PM) on 16.04.2020, the last date and time fixed by the Company for receipt of the forms were considered for my scrutiny and none of the envelopes containing the postal ballot forms received after the business hours (i.e.05.00 PM) on 16.04.2020.
7. The postal ballot envelopes were opened from time to time, under my authorization by the RTA and the last lot was opened on 11.06.2020 in the presence of two (2) witnesses not being employees of the Company.
8. The postal Ballot forms were scrutinized and details of shareholders were matched with the Register of Members of the Company.
9. I did not find any defaced or mutilated ballot paper.
10. A summary of the postal ballot papers received and e-voting is given below:

In brief total votes cast for special resolution is 99.99% and total votes cast against special resolution is 0.01% and therefore the aforesaid special resolution has been carried through with the requisite majority.					

The voting results of postal ballot, pursuant to the time limit as stated under Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with applicable provisions of the Companies Act, 2013 ('Regulation'), was scheduled to be declared on or before Saturday, 18.04.2020. However, the Government of India has with effect from the midnight of 24.03.2020 ordered complete lockdown limiting the movement of the people in the country as a preventive measure against outbreak of Covid-19 pandemic in India. Pursuant to the aforesaid order, my office, the offices of the Company and that of Registrar and Share Transfer Agent ('RTA') of the Company were shut temporarily. Consequently, the RTA was unable to deliver the physical postal ballot paper and therefore I could not furnish results of the of postal ballot notice dated 07.03.2020 on or before 18.04.2020.

I further report that on account of "Unlock-1" which was undertaken by the Maharashtra State Government from 08.06.2020, I could able to formalise my report and forward the same to the Chairman/Authorised Director of the Company.

I further report that as per Rule 22 of the Companies (Management and Administration) Rules, 2014, I maintained the records including the data as obtained from CDSL for e-voting facility extended by them and also Register recording the consent or otherwise received from the members, voting through Postal Ballot which includes all the particulars of members such as the names, folio number, DP ID/Client ID number of shares held, number of shares voted, no. of shares assented, no. of shares dissented, no. of shares rejected, ballot paper and other related papers are in my safe custody which will be handed over to the Company Secretary of the Company after the Chairman/any other Authorised Director approves and signs the Minutes of the Meeting.

You may accordingly declare the result of the said Voting Process.
