Dear Sirs

As you are aware, we were appointed as the statutory auditors of The Mandhana Retail Ventures Limited ('the Company') pursuant to the shareholder's resolution dated 20 September 2017 to hold office for a period of 5 consecutive years.

We have completed our statutory audit in respect of financial statements for the year ended 31 March 2020 and issued the audit report on 18 September 2020. We have also completed the limited review for the quarter ended 30 June 2020 and for the quarter and year to date period ended 30 September 2020 and issued limited review reports on 06 November 2020 and 12 November 2020 respectively.

As per our discussions/ communications with you/ management from time to time, we understand that the Company's business operations are significantly affected due to expiry of relevant license agreement and the current COVID-19 situation. Consequently, the Management has proposed a substantial reduction in audit fee for the financial year ending 31 March 2021 which is not commensurate with the efforts involved. It may also be noted that the audit process for the year ended 31 March 2020 was significantly delayed and a disclaimer of opinion on going concern assumption was issued.

In view of the above, pursuant to SEBI circular no. CIR/CFD/CMD1/114/2019 dated 18 October 2019, on 'Resignation of statutory auditors from listed entities and their material subsidiaries', we do not intend to continue as an auditor of the Company thereafter.

As per the requirements of the Companies Act 2013, we shall provide you, with the copy of the ADT-3, as filed with Registrar of Companies, in due course.

Please find attached in Annexure A, the information to be obtained by the Company from the auditors for the resignation as required by Securities and Exchange Board of India circular CIR/CFD/CMD1/114/2019 dated 18 October 2019.
